• The NFA published its **Election Manifesto 2017** last week, highlighting our key asks for all political parties.

- In response to the Housing White Paper the NFA is continuing work with ARCH, CIH, CIPFA, two councils and one ALMO on developing bespoke deals with Government to increase council house building. We are now waiting to reengage with civil servants after the election.

Housing News

The Homelessness Reduction Act 2017 was given Royal Assent on 27th April.

The House of Commons Public Accounts Committee has said in its latest housing report that the Government lacks ambition in addressing housing need and that the problems of homelessness and affordability are likely to persist for vears.

The Smith Institute report on the opportunities and limits of devolution on housing.

The CIH & University of Sheffield research on the work the councils and housing associations do together to tackle homelessness will be published in autumn.

A Commons Library briefing has been published on Cuts to Housing Benefit for 18-21 Year Olds.

Department for Work and Pensions (DWP) has published a list of regulations and statutory instruments relating to the Welfare Reform Act 2012

Research on behalf of the NHF has found that eight out of 10 Mancunians now agree there is a shortage of affordable homes in Greater Manchester.

Universal Credit

The DWP has argued that three million households across the country will keep more of what they earn due to change in the taper rate, the rate at which a Universal Credit payment reduces as someone moves into work. This will be lowered from 65p to 63p. The change means that some households could benefit by £425 a

Statistics

A new housing research centre (CaCHE) will bring together nine UK universities, the National Institute of Economic and Social Research, the CIH, the Royal Town Planning Institute and the Royal Institution of Chartered Surveyors.

The DWP has published the latest experimental statistics covering the total live caseload, starts and claims for Universal Credit.

DCLG data is available on estimates of the number of dwellings in England as at 31 March 2016.
